1. **INSTRUCTION TO BIDDERS**

- 1.3 Due date of submission of the bid will be on 17/03/2023, **up to 15:00 Hrs**. The bid will be opened on the same day at **15:30 hrs** in the presence of tenderers or their authorized representatives who wish to present.
- 1.4 The tenders once submitted shall remain valid up to 120 days and the tender will not be entitled to withdraw the tenders or to suggest any change therein within the said period.
- 1.5 Tenders should contain complete specification of the item with drawing and make.
- 1.6 The total accumulated value of all he tendered items including Tax, Transportation, Packing and Forwarding etc. will be taken into consideration for arriving L1 vendor.
- 1.7 As the dining Table and chairs are required for this Institute, the timeline of service informed in the tender without fail.
- 1.8 The tender submitted through Email or Fax will not be considered.
- 1.9 This Institute will not in any case be responsible for any delay on the part of postal/courier people for late delivery of the quotations.
- 1.10 All pages should be duly signed by authorized signatory with company seal.
- 1.11 Noncompliance of terms and conditions by successful tenderer will lead suspension

- 1.12 PIIC reserves the right to award the tender to deserving parties either in full or in parts. The decision of PIIC is final and unquestionable.
- 1.13 The Tenderer should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Tenderer to submit undertaking to this effect along with bid.
- 1.14 PIIC reserves the right to increase or decrease the quantity to be ordered at the time of placement of order. Tenderers are bound to accept the orders accordingly.

3. Minimum Eligibility Criteria :

The tenderer has to be manufacturer or authorized dealer of the Scheduled item. In case of authorized dealer / agent, the Manufacturer's Authorization Certificate/Form (Manufacturer's Authorization Form to be submitted in Annexure IV) received from the manufacturer to be attached.

4. <u>Bid Evaluation :</u>

Bid determined to be substantially responsive will be checked by PIIC for any arithmetic errors and the same will be corrected as follows:

- a. Where there is a discrepancy between the rates in figures and in words, the rates in words will prevail.
- b. Where there is a discrepancy between the unit price and the total price resulting from the multiplying the unit price by the quantity, the unit price as quoted shall prevail.
- c. The tenderer quoting the rate shall quote only in Indian Rupees. **FOR PII COONOOR** price will be considered for comparison and evaluation.



5. <u>Tender Price & Documents:</u>

- a. The rate should be strictly offered in Indian Rupee.
- b. The price of the goods should be quoted strictly on FOR PII, COONOOR basis
- c. Any Sales or other taxes and any duties, which will be payable on the goods in India, should be borne by the supplier if the contract is awaited.
- d. Charges towards Freight, Packing & Forwarding, Inland Transportation, Insurance (local transportation and storage) would be borne by the supplier from their warehouse to PIIC.

FOR PII, COONOOR price only will be considered for comparison and evaluation

6. <u>EXEMPTIONS/FORMS:</u>

- 6.1 PIIC will not be giving any duty exemption, GST Concession form.
- 6.2 The tenderer who are currently registered and, also, will continue to remain registered during the tender validity period with Directorate General of Supplies & Disposals or with national small Industries Corporation, New Delhi shall be eligible for exemption from EMD. In case the tenderer falls in these categories, they should furnish copy of the valid registration details (with DGS&D or NSIC, as the case may be)

7. <u>REJECTION OF BIDS :</u>

Notwithstanding the above conditions, PIIC reserves the right to accept or reject any offer, and to annul the tender process and reject all offers, at any time prior to award of Contract without thereby incurring any liability to the affected Bidder or any obligations to inform the affected Bidder or Bidders of the grounds for PIIC action.

8. <u>NOTIFICATION OF AWARD:</u>

- 8.1 Prior to the expiry of the period of offer validity prescribed by PIIC, PIIC will notify the successful tenderer by Fax or email/ registered post/ by courier, that his offer has been accepted. The service order will be issued to the successful tenderer. No correspondence will be entertained by PIIC from the unsuccessful tenderers.
- 8.2 Upon selection of the successful tenderer PIIC will promptly notify the same to successful tenderer through a Purchase Order.

9. <u>PERFORMANCE SECURITY</u>

- 9.1 Successful tenderer will have to furnish Performance Security @ 3% of the total contract value in the form of a Demand Draft drawn in favour of "The Director, Pasteur Institute of India" payable at any Nationalized Bank in Coonoor (or) by NEFT to this Institute account directly.
- 9.2 Failure of the successful Bidder to furnish the required Performance Security shall constitute sufficient grounds for the annulment of the award of Contract and shall forfeit

the Performance Security.

- 9.3 Forfeiture of Performance Security: In case, the tenderer/ Bidder fails to complete the service, PIIC, without prejudice to rights and remedies available under the contract, shall forfeit and en-cash the Performance Security.
- 9.4 Non Compliance of Terms and conditions by successful tenderer will lead to suspension for participation of any tenderer for a period of one year.
- 9.5 The Performance Security will be refunded to you only after 3 months from the date of satisfactory completion of installation and submission of documents.

1. **DEFINITION:**

TERMS AND CONDITIONS

- 1.1 For the purpose of this contract, the following words and expressions shall have the meaning hereby assigned to them except where the context otherwise requires:
 - a. "PIIC" means Pasteur Institute of India, Coonoor, which expression shall unless excluded by or repugnant to the context include PIIC's representative.
 - b. "Tenderer/ Bidder" Means successful lowest bidder.
 - c. "Consignee" means the organization/person to whom the goods are required to be delivered as specified in the Contract. If the goods are required to be delivered to a person as an interim consignee for the purpose of dispatch to another person as provided in the Contract then that "another" person is the consignee, also known as ultimate consignee.

2. PAYMENT SCHEDULE:

Payment shall be made as specified in the contract in the following manner:

3. <u>TIME SCHEDULE</u>

- 3.1 The day of commencement of delivery period will be reckoned from the date of issue of purchase order.
- 3.2 The materials shall be delivered at site within 30 days from the date of issue of purchase order or as per delivery terms mentioned in the Purchase Order.
- 3.3 The supply shall be carried out with all due diligence and as per the time schedule specified above. In case of any delay/default, of the Bidder to adhere to the agreed time schedule. PIIC shall recover the liquidated damages from the Bidder at the rate of 0.5% (Zero point five percent) of the total amount of fee per week of delay of any activity subject to a maximum of 5% (Five percent) of the total order value. However, if there is a purposeful delay by the Bidder. PIIC reserves all right to terminate the contract and get the full work executed at his risk and cost.

4. <u>EXTENSION OF TIME</u>

- 4.1 To adhere to the above mentioned time schedule, the Bidder shall provide on demand necessary documents, information and certificates/undertakings to PIIC. Any delay in supplying the requisite documents and delay due to any other cause beyond the control of the Bidder shall be considered for grant of extension of time. If the Bidder require extension of time, they shall intimate in writing to PIIC within 3 working days of the occurrence of such hindrance/delay, along with proper documents.
- 4.2 PIIC after satisfying itself about the reasonableness of grounds may grant extension of time, if it is justified and communicated the same in writing. Whenever such extension of times is granted, it would be without prejudice to the rights of PIIC for any panel action to the extent of the delay attributable to the Bidder. Any extension of time granted as stated above shall neither entitle the Tenderer/Bidder to any claim for increase in their fees not shall it release him from any of the obligations under the said agreement.

5. <u>ABANDONMENT OF WORK</u>

- 5.1 If the Tenderer/Bidder abandons the supply for any reason whatsoever or becomes incapacitated as aforesaid. PIIC shall forfeit/en-cash the Performance Guarantee. PIIC shall be at liberty to make full use of all or any of material supplied by the Tenderer/bidder. The Tenderer/Bidder shall also be liable to refund all the charges paid to him up to date plus such damages as may be assessed by PIIC including the recovery of liquidated damages.
- 5.2 Provided, however, that in the event of the termination of the agreement under proper notice as provided in the clause hereinafter. The Tenderer/Bidder shall liable to refund any excess payment made to him over and above which is due to him in accordance with the terms of this agreement, for the work executed by him till the date of termination of agreement.

6. DETERMINATION AND RESCISSION OF THE TERMS & CONDITIONS

- 6.1 When the Tenderer/Bidder have made himself liable for action under any of the Clause Aforesaid, PIIC shall have powers.
- 6.2 To rescind the agreement to engage another Tenderer/Bidder to carry out the balance work Debiting the Tenderer/Bidder the extra amount, if any, so spent for getting the balance work done.
- 6.3 This amount would be in addition to the recovery of liquidated damages.

7. <u>GENERAL</u>

- 7.1 The Tenderer/Bidder shall be fully responsible for supply of the material and also ensure that the material is supplied as per the specifications.
- 7.2 The Tenderer/Bidder hereby agrees that the charges to be paid as provided herein will be in full discharge of functions to be performed by him and no claim whatsoever shall be made against PIIC in respect of any proprietary rights or copy right on the part of any other party relating to plans, models and drawings.
- 7.3 The Tenderer/Bidder shall indemnify and keep indemnified Pasteur Institute of India against any such claims and all costs and expenses paid by PIIC in defending such claims to be

7.4 The Tenderer/Bidder hereby agrees that PIIC shall have the right to take out any of the activities, which in the opinion of PIIC not being performed by the Tenderer/Bidder with due diligence, and within the agreed time schedule, and which can be performed independently. The fees or the expenses incurred shall be debited to the Tenderer/Bidder.

8. ARBIRATION

- a) All disputes or differences whatsoever arising between the parties out of or relating to the Tenderer/ Bidder services, meaning and operations or effect of this contract or the breach thereof shall be settled by arbitration. Matters to be arbitrated upon shall be referred to a sole Arbitrator, to be appointed by PIIC and the award made in pursuance thereof shall be binding on the parties. Such arbitration shall be governed by the Indian Arbitration and Conciliation Act 1996.
- b) The place of arbitration shall be at **Udhagamandalam.**

9. <u>FALL CLAUSE</u>

The prices charged for this particular service under the Contract by the service provider shall in no event exceed the lowest price at which the service provider sells the service of identical description to any person(s)/organization (s) including the Purchaser or any Department of the Central Government or any Department of a State Government or any statutory undertaking of the Central or a State Government, as the case may be, during the period till performance of all Supply Orders placed during the currency of Rate Contract is completed.

10. STATUTORY VARIATIONS

In case of statutory variation in regard to taxes/levies, within the stipulated date of completion of individual agreement, the same shall be paid or recovered as per the actual against documentary proof. However beyond this period PIIC will take advantage of any reduction in taxes/levies but will not pay extra on account of increase in taxes/levies.
