SCOPE OF SUPPLY

The scope of work is **LAYING OF 03MM THICKNESS EPOXY FLOORING** at various Laboratories in Pasteur Institute of India, Coonoor as detailed below :

- Epoxy recoating on existing epoxy flooring, viz. scraping and cleaning and painting on the existing floor surface : 2000 Sq.ft. (Approx)
- Providing, laying and carry out epoxy primer coat of 200 micron thickness and to apply as per manufacturing specification, providing and applying screed with minimum 1 mm thickness and carry out epoxy top coat of minimum 02mm thickness. : 3000 Sq.ft. (Approx)
- Rectification of undulation up to 3mm thickness using epoxy screed filter (coving work at wall and floor connecting portion) : 3000 R.Ft. (Approx)

TERMS AND CONDITIONS

Scope of Work :

Laying of epoxy coating flooring in different Laboratories.

- Epoxy recoating on existing epoxy flooring, viz. scraping and cleaning and painting on the existing floor surface with same colour : 2000 Sq.ft. (Approx.)
 - Epoxy floor re-topping by providing, laying and carry out epoxy primer coat of 200 micron thickness and to apply as per manufacturing specification, providing and applying screed with minimum 1 mm thickness and carry out epoxy top coat of minimum 02mm thickness with the existing colour : 3000 Sq.ft.
 - Rectification of undulation up to 3mm thickness using epoxy screed filter (coving work at wall and floor connecting portion) : 3000 rft.
 - i. Chemical resistant, anti-corrosive, anti-skid and electric resistant solvent free Epoxy Insulation Coating designed to be applied on Floor as an insulation mat for high level of insulation.
 - ii. Colour of the Epoxy coating is indicative only. However, the vendor has to match the colour of the Epoxy laying with the existing flooring.
 - iii. Load bearing capacity of Epoxy coating : Traffic with trolley movement with 300 Kg. weight and human traffic will be minimum around 5 persons average.
 - iv. Life of coating should be of not less than 5 Years. An undertaking or Original manufacturer and Supplier shall be submitted on company letter head with the bid.
 - v. Any peeling is observed during these 05 years should be rectified by supplier on free of cost.
 - vi. The product make should be ISO approved or any other certified agencies.
1. Cost of the work would be around 10.00 lakhs rupees approximately. The rate offered should be inclusion of Materials, Labour, Accommodation.
 2. The bidder should have minimum 2 years experience in this type work/similar work done for any Government Department/Organization/Company/Public Sector/Autonomous Body and pharmaceutical companies.
 3. The Quantity given in the bid is only tentative and exact quantity will be known and accounted only after completing the entire work.
 4. The bidder is solely responsible for SAFETY of Manpower & Material. Accordingly, the contactor must follow all safety rules & regulations of Laboratory Safety Laws in force and Government rules from time to time.

7. The vendor must have valid registration or trade license to carry /supply the said item. Copy should be submitted along with the bid.

Successful bidder shall be required to furnish Security Deposit/Performance Security within 15 days of issuance of work order by PIIC and before commencement of work. Amount of Security Deposit/Performance Security shall be 10% of the work order value i.e. Rs. 1.00 lakhs approx. The Security Deposit shall be deposited by successful bidder in the form of Demand Draft/RTGS Payment PIIC Bank Account and shall remain valid for a period of 12 months as detailed below:

12. If the successful bidder fails to fulfill the obligation under this Tender, i.e. Non-adherence to terms and conditions contained in this tender, PIIC after due notice to the supplier/agency, may black list the supplier/agency and the contract will stand terminated automatically.

35. FORCEMAJEURE CLAUSE :

If at any time during the continuance of the contract the performance in whole or part by either party of any obligation under the contract shall be prevented or delayed by reasons of war, hostility acts of public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God (Hereinafter referred to as events) hen provided notice of the happenings of any such events if given by either party or the other within twenty one days from the date of occurrence thereof, neither party shall by reasons of such event, be entitled to terminate the contract not shall either party have any claim for damage against the other whether in respect of such non-performance or delay in performance.

Deliveries or acceptance of deliveries under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist and the decision of PIIC as to whether the deliveries or acceptance of deliveries have to be so resumed or not shall be final and conclusive, provided further if the performance in whole or part or any obligation under the contract is prevented or delayed by reasons of any such event for period exceeding 60 days either party may at its option terminate the contract.

36. ARBITRATION CLAUSE :

Except, as otherwise provided elsewhere in the contract, if any dispute, difference, question, or disagreement arises between the parties hereto or their respective representative or assignees, at any time, in connection with, meaning, operation, effect, interpretation or out of the contract or beach thereof, the same shall be referred to decide by an Arbitrational Tribunal consisting of three arbitrators. Each party shall appoint one arbitrator and arbitrators so appointed shall appoint third arbitrator who will act as Presiding arbitrator. Subject as aforesaid the Indian Arbitration and Conciliation Act, 1996 shall apply to the arbitration proceedings under the Contract.
